

# *GSWS Call for Entries*

## **Garden State Watercolor Society Forty-First Annual Juried Exhibition September 11 through November 7, 2010**

**Trenton City Museum at Ellarslie Mansion, Cadwalader Park, Trenton NJ (609) 989-3632  
Gallery Hours – Tuesday – Saturday 11AM-3PM – Sunday – 1- 4 PM – Public Holidays Closed**

**AWARDS:** Cash and other prizes worth thousands of dollars including the Nummie Warga Memorial Award of \$2000.

**JURORS:** Kass Morin Freeman, AWS, NWS – Donald Patterson, AWS, NWS

**ELIGIBILITY:** The exhibition is open to all current Garden State Watercolor Society members and any artist over 18 years of age residing in the State of New Jersey.

### **SPECIFICATIONS:**

- Artists may submit one original watercolor painting, on unvarnished paper, properly matted and framed. Yupo substrate is permitted.
- All entries must be **original** in both design and execution, not copy. Source material must be from your own design or your own photograph. No class work.
- Artwork must have been created within the past three years and not previously exhibited in any Garden State Watercolor Society show or at the Trenton City Museum.
- Artwork must be water-based media, including watercolor, gouache, acrylic, casein, ink, and egg tempera. Water media collage is acceptable, but watercolor must be the dominant element. Water-based oils not permitted.
- Artwork must be suitably framed and wired for hanging. No saw tooth clips will be accepted. Artwork may not exceed 50" in any direction, including framing. The minimum size accepted is 14" X 16". Artwork exceeding 36" in any direction must be presented under Plexiglas. Garden State Watercolor Society and Trenton City Museum will not be responsible for frames and/or glass broken due to improper framing.
- Accepted artwork must remain at the Trenton City Museum for the duration of the exhibit. No exceptions.

**ENTRY FEES:** GSWS Full and Associate Members - \$20.00 – Non-members \$45.00 – Checks payable to GSWS.

**SALES COMMISSION:** All artwork must be priced or marked NFS. A commission of 30% is taken on all sales to benefit Trenton City Museum and Garden State Watercolor Society.

**LIABILITY AND INSURANCE:** The Trenton City Museum will insure the artwork from the time it is received at the museum, until said artwork is picked up by the artist or an authorized representative. The insured amount of the artwork may not exceed 70% of the sale price. Accepted work must be available for the duration of the exhibit and will not be removed for any reason until 4:00PM on November 7, 2010. GSWS and Trenton City Museum reserves the right to reproduce exhibition entries for publicity purposes. Trenton City Museum and GSWS will not be responsible for artwork remaining after the specific pick up date. Submission of any entry constitutes the artist's acceptance of these terms.
